**DECLARATION OF MICHAEL BUI**

I, Michael Bui hereby declare:

1. I am employed as a Case Manager by Simpluris, Inc. ("Simpluris") the claims administrator in the above-entitled action. My business address is 3176 Pullman Street, Suite 123, Costa Mesa, CA 92626. My telephone number is (714) 640-5630. I am over twenty-one years of age and authorized to make this declaration on behalf of Simpluris and myself.

2. Simpluris, Inc. is a Class Action Settlement Administration company located in Costa Mesa, CA. 

5. The check cashing period expired on December 18, 2016, which was 365 days from the issuance date of November 18, 2015. As of January 9, 2017, there are thirty-eight (38) un-cashed checks totaling \$5,696.40.

6. Pursuant to the Stipulated Class Settlement, settlement checks which are not negotiated within three hundred sixty-five (365) calendar days after the date they are mailed shall be void. Such monies and any other funds not disbursed or negotiated as part of the Settlement shall be transmitted to the State of California Controller's Office Unclaimed Property Fund in the names of Participating Class Members.


