The Intendance for Supervision and Regulation of Non-Financial Subjects is responsible, in the administrative channel, for supervising and regulating non-financial obligors and the activities carried out by professionals subject to supervision regarding the prevention of money laundering, financing of terrorism and financing of proliferation of weapons of mass destruction; in accordance with the provisions of Law 23 of April 27, 2015

Pursuant to Articles 23 and 24 of the aforementioned law, non-financial obligors are defined as professionals who carry out activities subject to supervision, including lawyers when in the exercise of their professional activity, perform any of the listed activities on behalf of a client or for a client.

Currently, the Regulatory Unit of the Intendance for Supervision and Regulation of Non-Financial Subjects has been filed a Sanctioning Process for alleged breaches of Law 23 of April 27, 2015; in which it becomes necessary to provide the certifications of the following legal entities
